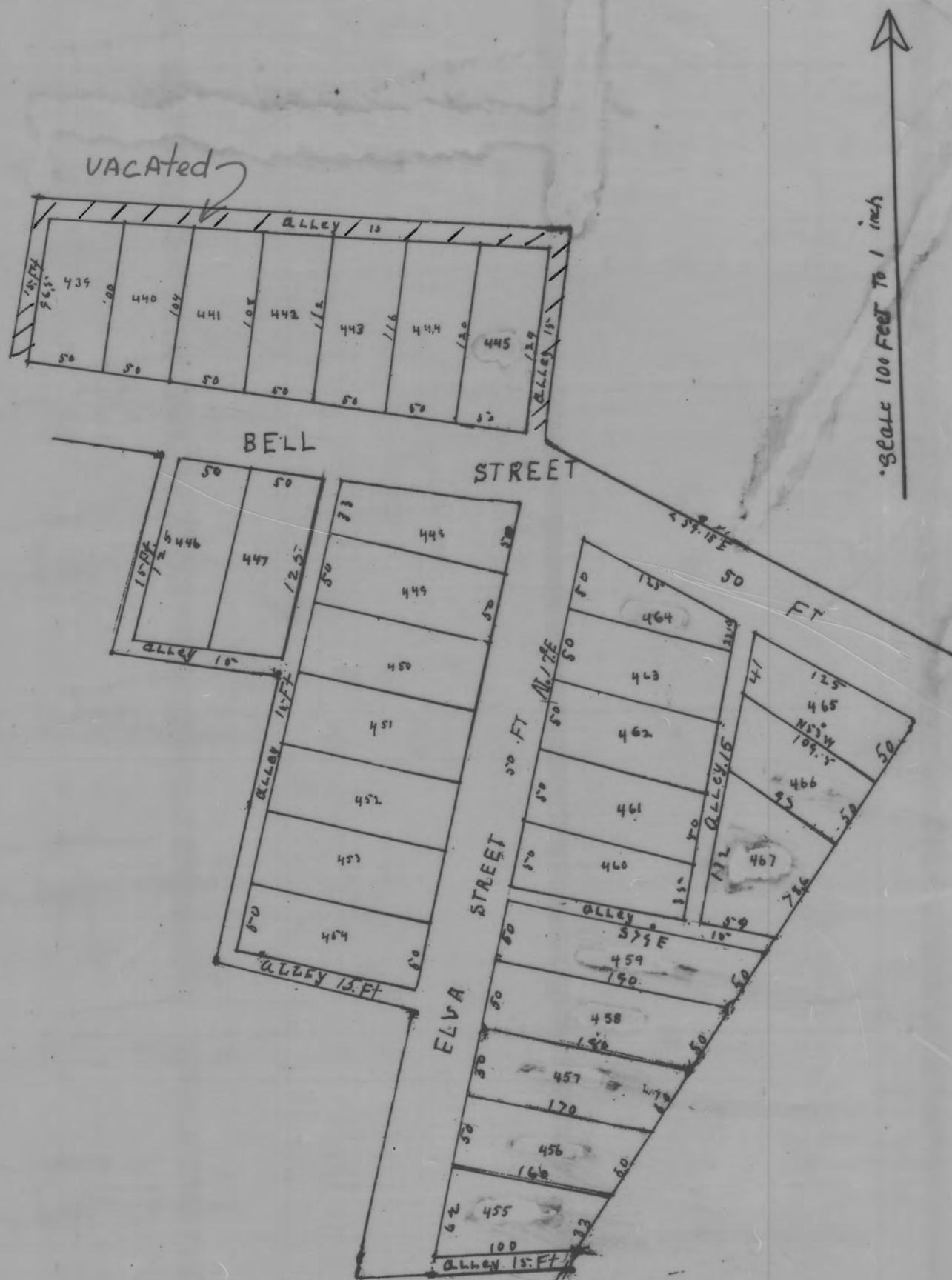


BELLS FIRST ADDITION TO CROOKSVILLE

Being part of the South West Quarter of Section 16, Township 14, Range 14, and Commencing at the South East corner of said quarter, thence west 1566 ft. to the place of beginning, thence N. 85° 2' W. 150 ft. thence S. 17° 2' E. 150 ft. thence N. 72° 2' W. 175 ft. thence N. 15° 2' E. 100 ft. thence N. 17° 2' E. 400 ft. thence S. 80° 2' W. 115 ft. thence S. 17° 2' E. 440 ft. thence S. 80° 2' W. 120 ft. thence N. 10° 2' E. 161.5 ft. thence S. 86° 2' E. 365 ft. thence S. 10° 2' W. 138.8 ft. thence S. 57° 15' 32.0 ft. thence S. 35° 2' W. 425.6 ft. to the place of beginning containing 586 Acres.
