

To Authorize annexation of certain territory to the village of Crooksville, Perry County, Ohio. Whereas, it is here found, ordered and declared by the Council of said village that the Inhabitants generally of said municipal corporation of Crooksville, Perry County, Ohio, desire to enlarge its corporate limits by the annexation of the contiguous territory hereinafter described, and therefore be it ordained by the council of said village of Crooksville Perry County, State of Ohio: Section 1. That the annexation of the following described territory, to wit: Beginning at the north east corner of the northwest quarter of section No. 21, Township No. 14, range No. 14 Perry County, Ohio; thence north twenty six hundred and forty feet; thence west eighteen hundred and ten feet; thence north thirty six and a half degrees east, sixteen hundred and seventeen feet; thence west seventeen hundred and eighty five feet; thence south thirteen hundred and twenty feet; thence west twenty six hundred and forty feet; thence south thirteen hundred and twenty feet; thence west Thirteen hundred and twenty feet; thence south thirteen hundred and twenty feet; thence east thirteen hundred twenty feet; thence south twenty six hundred and forty feet; thence east twenty nine hundred and sixty feet; thence south twelve and a half degrees east ten hundred and sixty feet; thence east two thousand and sixty eight feet; thence north three thousand six hundred and eighty feet to the place of beginning, containing exclusive of the present corporation five hundred and sixty eight and sixty five one hundredths acres and being all of said territory embraced within the above described boundary and outside of the present boundary line of the corporation of Crooksville, which is as follows, to wit: Beginning at the north west corner of the north east quarter of section No. 20, township No. 14, range No. 14, Perry County, Ohio; thence north six hundred and thirty four feet; thence south eighty two and a half degrees east: two hundred and sixty eight feet; thence south eighty degrees east one hundred and forty two feet; thence south seventy seven and one fourth degrees east seven hundred and forty one feet; thence south seventy five degrees east two hundred and eighteen feet; thence south sixty two degrees east two hundred and twelve feet; thence south forty seven and a half degrees east: three hundred and forty nine feet; thence east two thousand one hundred and thirty feet; thence south twenty two and three fourth degrees east: seven hundred and ninety feet; thence south fifty two and a half degrees west three hundred and thirty three feet; thence south nineteen degrees east: twelve hundred and seventy three feet; thence south twenty five and a fourth degree east one hundred and ninety feet; thence west twenty six hundred and seventy five feet; thence north eight and a fourth degree west six hundred and sixty nine feet; thence north eighty and three fourth degree west one hundred eighty eight feet; thence north five and a half degrees west one hundred and sixty five feet; thence south seventy six and a half degrees west two hundred and thirty feet; thence north eight and three fourths degree west one thousand one hundred and seventeen feet; thence west two hundred and eight feet; thence north nine and a half degrees west one hundred and sixty feet; thence north eighty six degrees west two hundred and fifty eight feet; thence south eighty seven and a fourth degree west one hundred and ninety eight feet; thence north three and one half degrees west one hundred and ninety eight feet; thence west two hundred and forty three feet; thence north three and one half degrees west three hundred and ninety five feet; thence west two hundred and twenty nine feet to the place of beginning, to the Village of Crooksville, Perry County, Ohio, be and the same is hereby authorized.

Section 2. That the Solicitor, Emmett C. Brannon, be and he is hereby authorized to prosecute the proceedings necessary to effect such annexation.

Section 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law
