Beginning at the north west corner of the east half of said quarter section, thence S 33° 40' W 765 feet to the right of way of the C.A.T.C. Ry. thence with the right of way of a switch of the C.A.T.C. Ry. with a curve having a radius of 598.7 feet for a distance of 478 feet to the right of way of the South Eastern Ohio Electric Railway thence along the right of way of the S.E.O. Elec. Ry. N 44° 47' E 128.6 feet, thence N 45° 13' W 124 feet. thence along right of way of said Ry. N 43° 55' E 204 feet. thence N 84° 40' W 1172.3 feet to the place of beginning containing 17 1/2 acres. Have caused the same to be surveyed and plotted into lots and streets that we dedicate the streets to the public as highways. That said subdivision shall be known as Crescent Heights.
