Ordinance No. \_\_\_\_\_

An ordinance giving the assent of the council of the village of Shawnee, Perry County, Ohio, to detach certain territory from said village.

Be it ordained by the council of the village of Shawnee, Perry County, Ohio, as follows:

Section 1. That it is deemed to be for the best interests of the village of Shawnee, Perry County, Ohio, and assent is hereby given by the council to detach from said village, the following described portion, territory to-wit:

Beginning at the north west corner of section 21, Salt Lick Township, Perry County, Ohio; thence east along the north line of section 21 a distance of 2550 feet more or less, to the south line of lot 368. Thence south easterly along the south lines of lots No's 368, 367, 366, 365 and 362 a distance of 340 feet more or less to the south east corner of Lot No. 362. Thence northerly along the east line of Lot No. 362 a distance of 50 feet more or less to the north east corner of Lot No 362. Thence northerly along the east line of Lots No's 363 and 364 a distance of 86 feet more or less to the north line of section 21. Thence east along the north line of section 21 a distance of 350 feet more or less to the west line of lot No. 329. Thence south easterly along the west line of lot No 329 a distance of 50 feet more or less to the south west corner of lot No 329. Thence easterly along the south line of lots No's 329 to 314 inclusive a distance of 790 feet more or less to the west line of the north east one quarter of the north east one quarter of section 21. Thence north along the west line of the north east one quarter of section 21 a distance of 78 feet more or less to the north line of section 21. Thence east along the north line of section 21, a distance of 1320 feet more or less to the north east corner of section 21. Thence south along the east line of section 21 a distance of 3940 feet more or less to the north east corner of the south half of the south east one quarter of section 21. Thence west along the north line of the south half of the south east one quarter and the south half of the south west one quarter a distance of 5370 feet more or less, to the west line of section 21. Thence north along the west line of said section 21 a distance of 3960 feet more or less to the place of beginning.

Section 2. This ordinance shall take effect and be in force from and after its passage and legal publication
