

Notice is hereby given that on the 30th day of March, 1914, there was presented to the Board of Commissioners of the county of Perry, State of Ohio, a petition signed by a majority of the freehold electors residing in the following described territory situated in the county of Perry, State of Ohio, and being a portion of the incorporated village of Shawnee, to wit:

Beginning at the North West corner of Section 21, Saltlick Township, Perry County, Ohio, thence east along the north line of section 21 a distance of 2550 feet more or less to the south line of Lot No. 368. Thence south easterly along the south lines of lots No's 368, 367, 366, 365 and 362 a distance of 840 feet more or less to the south east corner of Lot 362. Thence northerly along the east line of lot No. 362 a distance of 50 feet more or less to the north east corner of Lot No 362. Thence northerly along the east line of Lot No 368 and 364 a distance of 86 feet more or less to the north line more or less to the North East corner of Lot No 362. Thence northerly along the east line of Lot No 329. Thence south easterly of said section 21. Thence along the north line of section 21 a distance of 350 feet more or less to the west line of Lot No 329. Thence easterly along the south line of lots No's 329 to 314 inclusive, a distance of 790 feet more or less to the west line of the north east one quarter of section 21 a distance of 188 feet more or less to the north line of section 21. Thence East along the north line of section 21 a distance of 1320 feet more or less to the north east corner of the south half of section 21. Thence south along the east line of said section 21 a distance of 3940 feet more or less to the north east corner of the south half of the south east one quarter of section 21. Thence west along the north line of the south half of the south east one quarter and the south half of the south west one quarter a distance of 5370 feet more or less to the west line of section 21. Thence north along the west line of said section 21 a distance of 3960 feet more or less to the place of beginning.

Said petition praying therein that said described territory be detached from said village of Shawnee, in the manner provided by law and designating therein M. W. Bradshaw of Shawnee, Ohio, as the agent of the petitioners for said purpose.

The said Board of Commissioners has designated Monday, June 1st, 1914, as the time for hearing said petition at the office of the Commissioners, of said county, in the village of New Lexington.

In the Matter of detaching certain territory from the village of Shawnee and attaching the same to Saltlick Township, Perry County, Ohio } A.K. Petition

Entry. Order Detaching Territory From Municipal Corporation and Attaching to Contiguous Township.

This day this cause came on for hearing before the Board of Commissioners of Perry County, Ohio; and the Board being fully advised in the premises, finds that the Petition herein is signed by a majority of the freehold electors owning lands in the portion of the territory of the municipality sought to be detached herein and attached to said Township. That such portion of territory is accurately described in said petition and that an accurate map and plat thereof accompanies the same.

And this Board of Commissioners further find that the Council of the village of Shawnee duly passed an ordinance for that purpose, giving its consent to the detachment of said territory, and in the matter of the apportionment of existing indebtedness of said municipal corporation, it has been ascertained by said Board of Commissioners that the amount of existing indebtedness of said municipal corporation is the sum of \$30,900 and that the portion that Saltlick Township shall assume and pay thereof is the sum of \$4,428.99 which said apportionment is made in accordance with the valuation as appears upon the tax duplicate of the territory interested herein, to wit: The Village of Shawnee on the one hand and Saltlick Township on the other, and said Commissioners further find that said territory ought to be detached from the village of Shawnee and attached to Saltlick Township.

It is, therefore, by the Board of Commissioners of Perry County, Ohio ordered, and directed that the territory described in the Petition in this cause be and the same hereby is detached from the village of Shawnee, Perry County, Ohio, and attached to the Township of Saltlick, Perry County, Ohio

And it is further ordered that the Petition, map, ordinance and this order of the Commissioners be certified by the County Auditor to the County Recorder of this County, and shall be recorded by him in the plat book in his office.
