*Asbery Garling's Addition

Asbery Garling's Addition to the Village of Newlock is situated in the west half of section 24, Township 14, Range 16, and commencing at the south east corner of the north west quarter of the south east quarter of said section 24, thence north 440 feet to a stake, the place of beginning, thence north 1218 feet to a stake, thence west 1283 feet, thence south 433 feet, thence east 670 feet, thence S. 23° E. 123 ft, thence S. 54° E. 157 feet, thence S. 35° E. 126 feet, thence S. 18° E. 280 to a stake, thence east 190 feet to a stake, thence south 273 feet to a stake, thence S. 57° E. 143 feet, thence North 100 feet, thence East 73 feet to the place of beginning, containing 175<sup>00</sup> acres, Lot No. 78 contains <sup>4</sup>/<sub>100</sub> of an acre, lot No. 79, <sup>3</sup>/<sub>100</sub> of an acre, Lot No. 80 <sup>4</sup>/<sub>100</sub> of an acre, Lots 81-82-83-84-85-86-87-88-89-90-91 and 92 contains <sup>2</sup>/<sub>100</sub> of an acre, Lot 93, <sup>1</sup>/<sub>100</sub> of an acre, 94-95-96 and 97 contains <sup>4</sup>/<sub>100</sub> of an acre, Lots 98-99-100-101-102-103-104 contains <sup>2</sup>/<sub>100</sub> of an acre, 105-106-107-108-109-110-111-112-113-114-115-116-117 contain <sup>4</sup>/<sub>100</sub> of an acre, 118, <sup>7</sup>/<sub>100</sub> of an acre, 120 <sup>2</sup>/<sub>100</sub> of an acre, Lot 122. <sup>3</sup>/<sub>100</sub> of an acre, Lots 119-121 each contain <sup>4</sup>/<sub>100</sub> of an acre, the width of streets and alleys is marked on plat, corners stones are planted at the following places: at the south west corner of lot 81, the south west of 94 and the S. E. of 115, Variation on N. & S. Lines 3° 15" Left on E. & N. Line 1° 3"

Know all men by these presents that I, Asbery Garling, of Perry County, Ohio, do hereby dedicate the streets and alleys as laid out in accompanying plat to Public use. In testimony whereof I have hereunto set my hand and seal this 20 day of October, A. D. 1890
