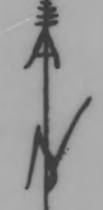


THE VILLAGE OF PROSPER.

The Village of Prosper is situated in the South west quarter of Section 3 Township 13 Range 14 commencing at the South East corner of said Section 3 thence West 233 ft thence N 7 1/2° W 240 ft on West Side of the C. & N. R. R thence N 73° W 248 ft to a County Road thence S 182° W 687 ft thence S 54° E 219 ft thence S 36 1/2° W 100 ft thence S 54° E 299 ft thence East 200 ft to the place of beginning containing 5 7/10 Acres lot No. 1 contains 1 15/100 Acres lots 2, 3, 4, 5, 6, 7 & 8 contains 2/10 of an acre lot No. 9 contains 3/10 of an acre lot No. 10 contains 1/10 of an acre lot No. 11 contains 1/10 A. lot No. 12 contains 1/10 of an acre lot No. 13 contains 1/10 A lot No. 14 contains 1/10 of an acre lot No. 15 2/10 A lot 16, 17, 18 & 19 each 7/10 A lot 20 1/10 A lot 21 2/10 A lot 22 1/10 A lot 23 1 A lot 24 1 A. 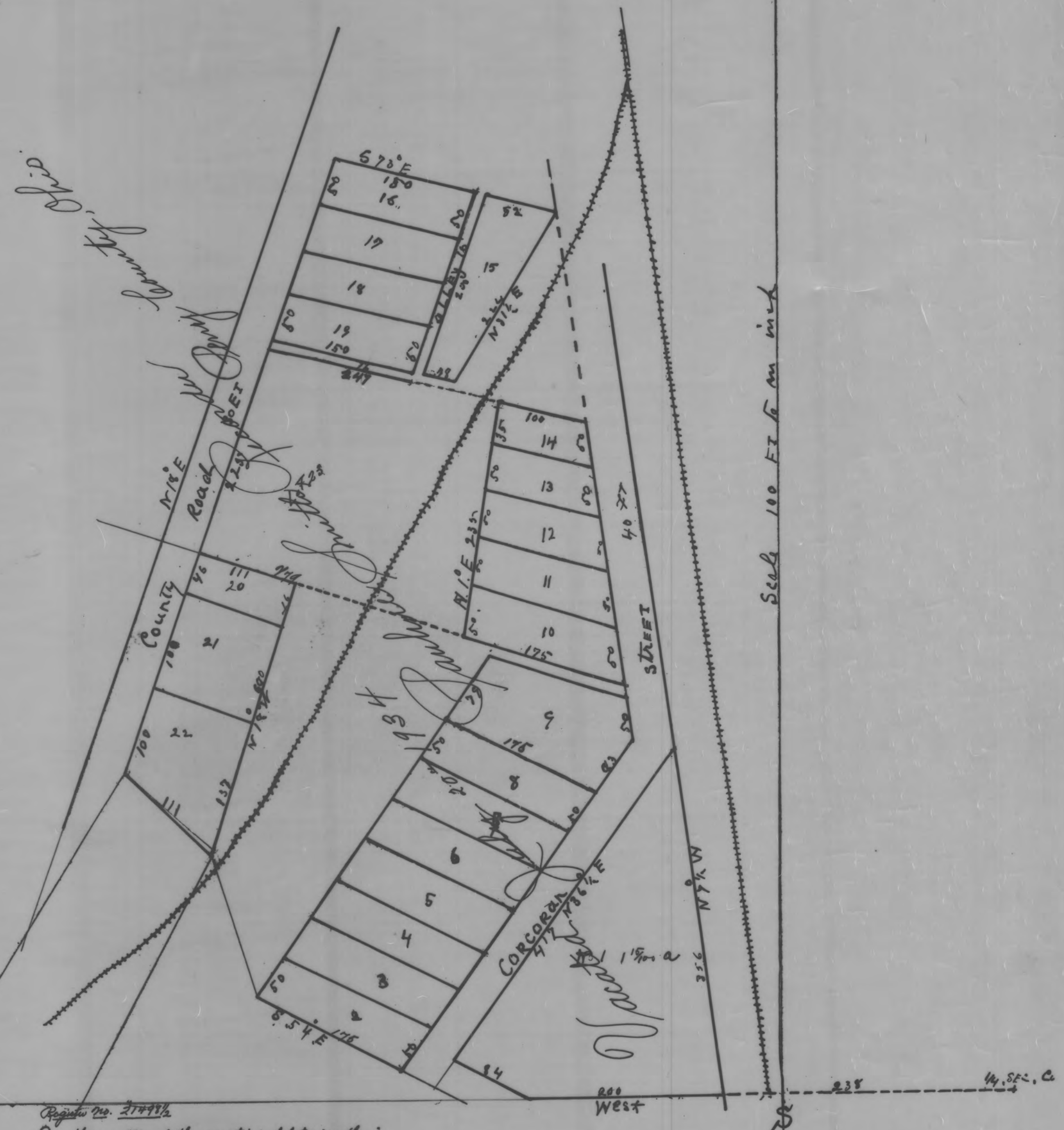

Jones Company is the owner of said lots described in said notice: Therefore this day by virtue of the power vested in me by Sections 3601, 3602, and 3603 of the General Code of Ohio, I do declare said lots described in said notice vacated, and a certificate of said fact is hereby issued to The George M. Jones Company in conformity to said statutes.
