

DESCRIPTION OF PLAT

This tract is a part of the Northeast Quarter of Section 5, Twp. 18-Rg. 17, Thorn Township, Perry County, Ohio, and is further described as follows:

Commencing at a stone at the Southwest Corner of the Northeast Quarter of Section 5, Twp. 18-Rg. 17; thence S-85° 13' E with the half Section line a distance of 1008.76 feet; thence N-2° 11' E a distance of 17.5 feet to an iron pin the place of beginning; thence continuing N-2° 11' E a distance of 4500 feet to an iron pin; thence N-2° 42' W a distance of 969.8 feet to an iron pin; thence S 78° 13' E a distance of 123.9 feet to an iron pin; thence S 2° 42' E a distance of 946.0 feet to an iron pin; thence S 2° 11' W a distance of 462.3 feet to an iron pin; thence N 85° 13' W a distance of 120.1 feet to the place of beginning and containing 3.9 acres more or less.

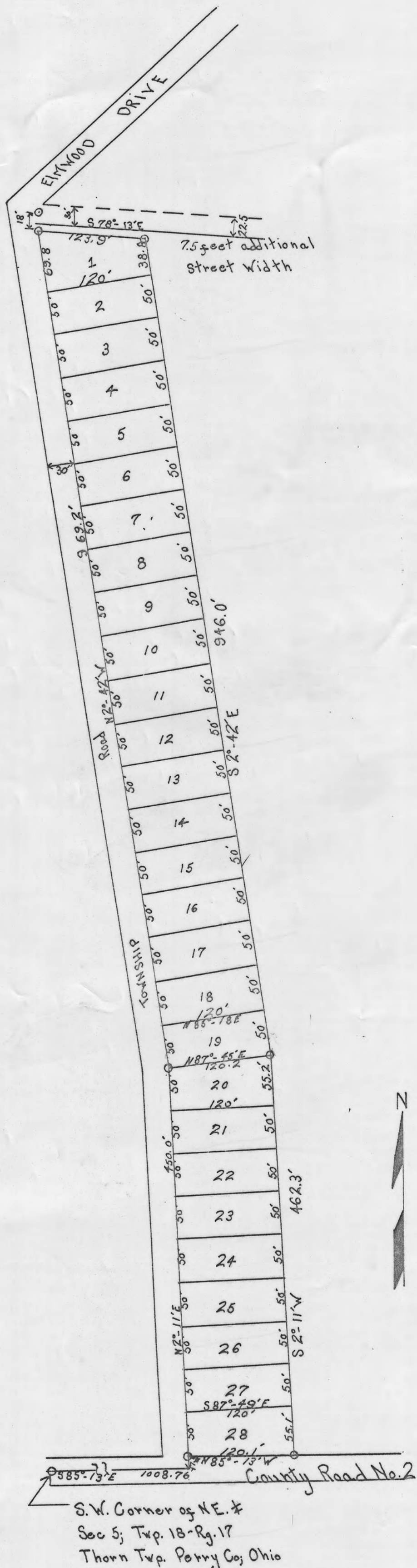
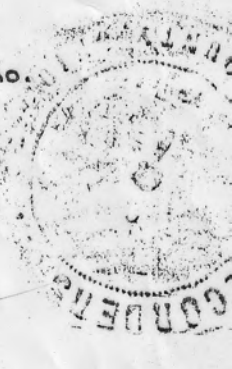
