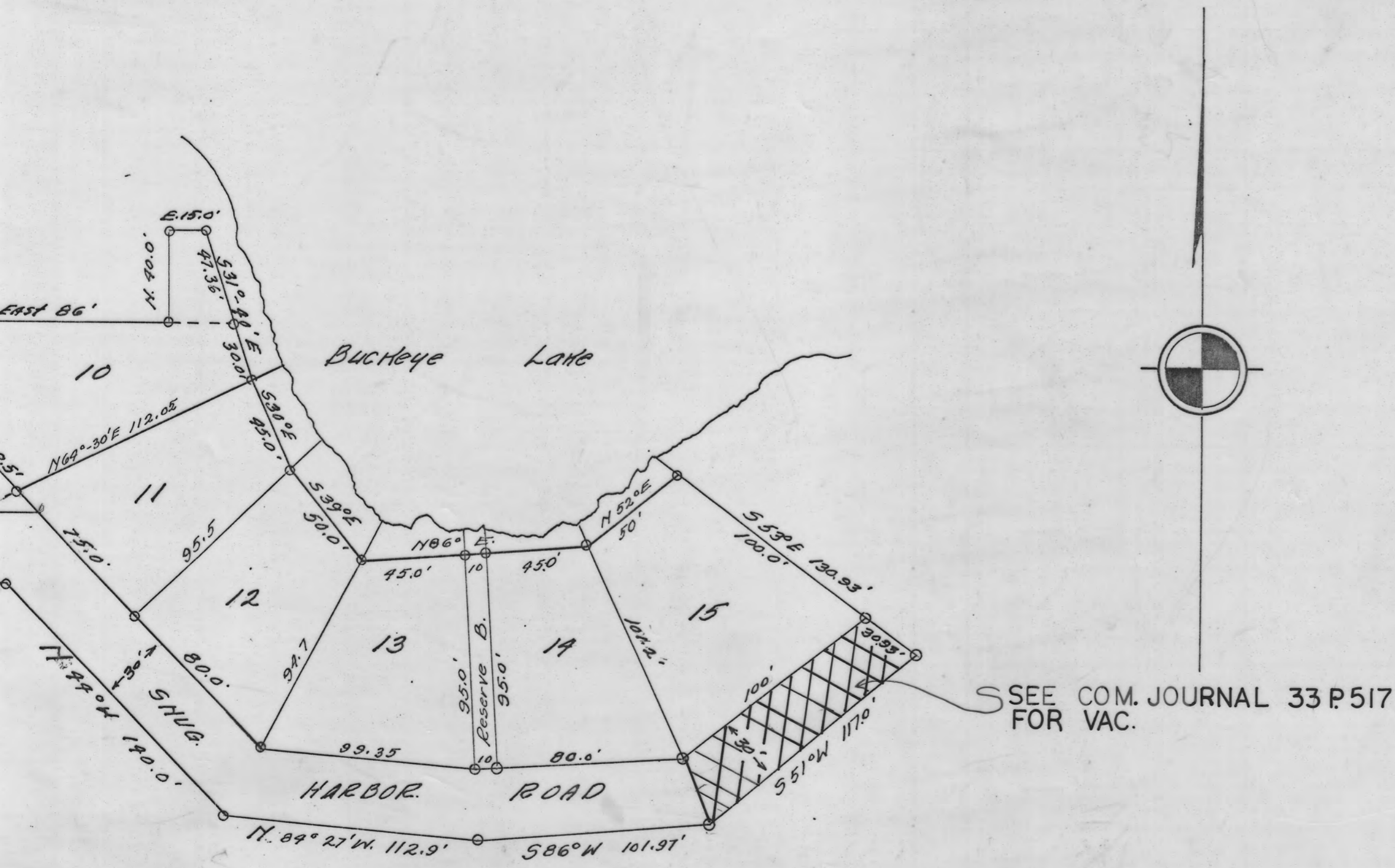


SNUG-HARBOR SUBDIVISION No 2 OF A PART OF SECTION No 6 T18-R17 PERRY COUNTY

In addition to the above bound tract a narrow tract approximately 5 ft. wide lying between Harbor Road and the waters edge is included, making in all 1.327 Acre more or less. All streets and reserves are as represented on this Plat, with dimensions given in decimal parts of a foot. All streets show hereon are hereby dedicated to public use. Streets are numbered from 10 to 15 inclusive.
