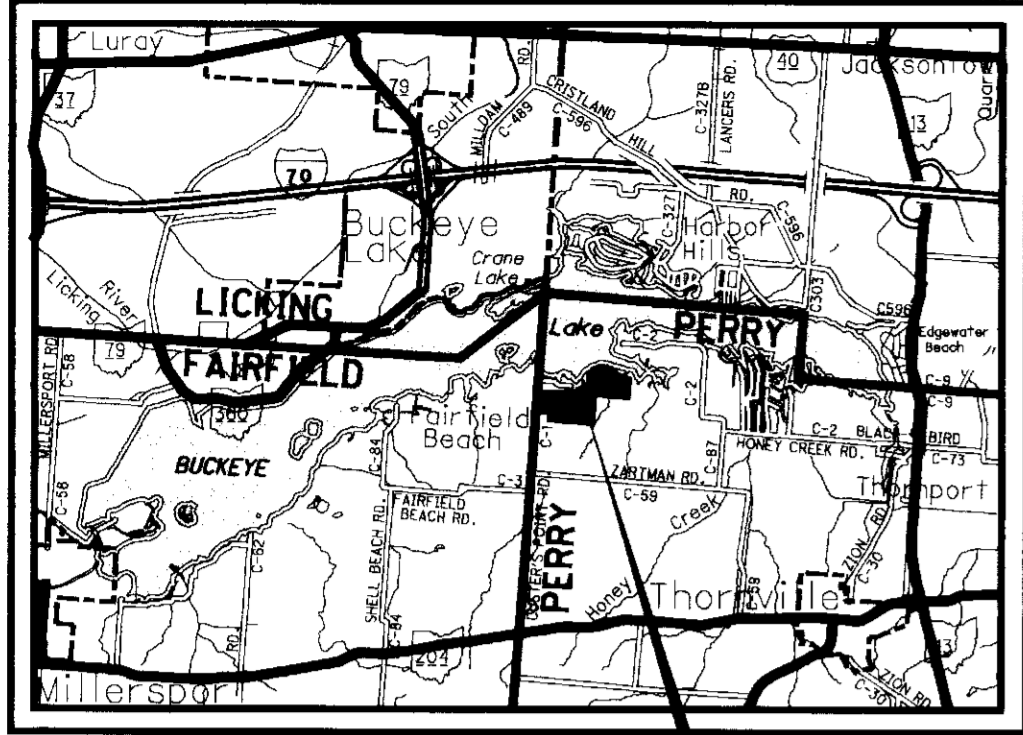


SNUG HARBOR PHASE II
